C&D; Biomass is a Renewable, Sustainable Energy Source

With a new administration coming into Washington DC, there is much uncertainty over what will be the renewable energy policies of the Department of Energy and the Environmental Protection Agency, including energy generated by secondary materials. Still, we have recently seen interest in the private sector for all types of renewable energy. Bill Gates is leading a group of wealthy investors to foster major advances in clean energy production, while Leonardo DiCaprio has a foundation that promotes renewable clean energy that could create millions of green jobs.

The C&D; recycling industry should be a part of any discussion on renewable clean energy. Our industry has tons and tons of dry, high Btu secondary wood material that is currently ending up in landfills around the country because of a lack of biomass markets. We C&D; recyclers know how to extract from the C&D; materials stream's wood the dirt, aggregates, drywall, and metals a gasifier or incinerator facility doesn't want. CDRA members can provide the feedstock these facilities need.

We are all aware that because of low prices for other energy sources, such as natural gas, the C&D; biomass market is a challenge. Still, C&D; biomass should be considered in any federal renewable energy policies. Already, the U.S. EPA recognizes the C&D; biomass as a legitimate fuel and not just the burning of waste to reduce volume. For example, the agency designated C&D; biomass a legitimate fuel and exempted it from its onerous Non Hazardous Secondary Material rule for waste fuels as long as common Best Management Practices are used. Said the agency in its final ruling on the exemption:

- "(T)he Agency has determined C&D; wood is not discarded when: it is
  processed in accordance with best management practices described herein, it
  is legitimately used as a product fuel in a combustion unit, and when
  combustors of C&D; wood have obtained a written certification from C&D;
  processing facilities that the C&D; wood has been processed by trained
  operators."
- "(C&D; biomass) demonstrates that processed C&D; wood has an average asfired energy content of 6,640 Btu/lb, which is greater than 5,000 Btu/lb, which the Agency considers to have a meaningful heating value."
- "The Agency compared the contaminant levels found in the processed C&D; wood to the contaminant levels found in clean wood and biomass materials since any unit burning processed C&D; wood can clearly burn clean wood and biomass materials as well...Agency finds that they support the final determination that processed C&D; wood meets the contaminant legitimacy criterion..." C&D; recyclers need to support any policy that considers C&D; biomass a renewable energy, which it is. Rest assured the CDRA will be working toward that goal.
