

CDRA Representing C&D Recyclers' Interests!

The Construction & Demolition Association has provided the C&D industry several successes over the years. Those are announced so members can take advantage of them, such as the C&D fines research or the modifying of regulations to make them less onerous and more common sense.

But sometimes the work of the CDRA is more sublime and not readily visible, such as when we have regular contact with regulators and legislators. A couple of recent examples of this happened the same week when the CDRA arranged for members to participate in conference calls with the U.S. EPA one day, and staffers for a U.S. Senator the next.

The EPA meeting was to discuss disaster debris and the role of recyclers in handling and perhaps processing of it. EPA had reached out to CDRA for the meeting, as our members are the recognized experts on building debris handling. We pointed out the challenges of recycling much of the storm debris but provided guidance on how concrete and metals should almost always be recovered.

Our discussion with the U.S. Senator's office was over proposed legislation to increase and improve recycling infrastructure in the United States. There was no mention of C&D in the draft bill from that office, but with our conversations, we were able to convince the staffers that the largest materials stream should be included. We feel there will be a satisfactory result in the final bill that will be introduced, but of course, changes will be made that we will stay on top of.

This all worked because members chose to become involved in the CDRA's projects, and to share their expertise and time. Consider sharing your time with the CDRA as we work to move the industry forward.

The Presentation: This webinar will address several aspects of this issue:


