This report is in the final review stages and will be available to CDRA members soon. And, next on their list is a committee review of the "**WARM Summary and Possible Alternatives Report to Estimate GHG Emissions**," also developed by the University of Florida team. This, too, will be available to CDRA members once it is finalized.
