Coronavirus Effect Blows Wind of Change

A microscopic organism in China has caused a hurricane of change.

C&D World 2020— one month in history. The U.S. entered March 2020 riding an 11-year economic expansion! Finding qualified workers and end markets to manage record volumes of reclaimed materials were the biggest challenges C&D recyclers faced. Attendees of C&D World in Las Vegas were optimistic, but the Covid-19 was casting a cloud of uncertainty, as described by Keynote Speaker Ed Sullivan, the economist who presented several possible outcomes. The economy exited March heading into one of the sharpest downturns on record.

Leaving Las Vegas: Returning from C&D World, the coronavirus had so suddenly transformed the marketplace that statistics, which look backward, resemble glimpses from a vanished world. Members grappled with protecting employees and regulations that a month ago were unimaginable. C&D markets are regional,



and the virus affect is no exception. A patchwork of lock downs varying from complete construction shutdowns, to merely slowing the pace, disrupted the industry.

(危机) Chinese word for “crisis” is “danger” and “opportunity”.

There is no doubt that a crisis causes many problems, but it also creates opportunity for transformational change. During each crisis, some companies disappear, others retreat and wait for a clear sign to return to normal that may never appear, and still others emerge stronger. As the economy reopens, we need to consider how the crisis and uncertainty in construction will influence the future of C&D recycling.

Resilience comes from working through difficult problems. There is considerable work ahead, but our strongest success comes from working together as the CDRA has a long history of doing. Staff and volunteers have responded with increased focus on rapidly evolving issues. Biweekly calls were held with recyclers spread across the country to evaluate market conditions and identify areas where the CDRA can assist.

New Normal Risk Management requires an entire new plan for managing pandemics. Most of our members and their employees are on the frontline and do not have the luxury of working from home. Pandemic guidance tailored to C&D Recycling is needed including employee education, hygiene, staff movement, sick leave policies, and absenteeism. Planning should also include operational issues—managing physical paperwork contact, supply chain and minimizing the interruption of essential services such as transportation and security.

Sustainability was a corporate America buzzword. The crisis changes this. The press reports municipalities and companies from Starbucks to General Motors paused some social responsibility programs such as curbside recycling and relaxing single use bans such as plastic bags and polystyrene. This change will most likely extend to C&D recycling.

Legislative and Regulatory issues are more important than ever as government takes a larger role in daily business activities. LEED projects have had C&D recycling interrupted due to the operational issues, and waivers need to be defined. There is renewed interest in an infrastructure stimulus and the CDRA needs to be at the table.

End Product markets will change in response to supply chain disruptions and reduced energy costs. Existing end markets need to be re-evaluated and new markets identified.

Collaborate Innovate Advance: The economic response to the coronavirus will play out over months and perhaps years, but opportunities will surface. They always do. Thanks to the dedication of volunteers who are some of the brightest minds in the industry and member generosity, the CDRA has the resources to tackle these issues, but we cannot act recklessly. The solution is us. Nobody is going to solve this for us. This is the moment for the CDRA to really come together.

End Markets Committee Update

There are so many things that connect us – as humans, as companies, as members of the CDRA! For businesses in the Construction & Demolition recycling industry, one area that connects us all is the need to have an outlet for the material that we process, transport, or create. In one way or another, whether you operate as a processor, hauler, or manufacturer of equipment, you are concerned about end markets. At the 2019 annual CDRA conference when asked what most impacted our members, in breakout groups that spanned regions and roles, end markets topped the list. Sparked into action by that feedback, the CDRA created an End Markets Development Committee with the aim of moving this area of our industry forward as a group.

The End Markets Development Committee's mission is to provide guidelines and other assistance in developing end markets for materials in the Construction & Demolition recycling industry. The committee had its first in-person meeting at the March 2020 C&D World conference in Las Vegas. Members came together and heard updates on internal guidelines for creating an end product as well as the CDRA collaborations with the University of Florida. One of the most high-volume materials in the industry is wood, while one of the most challenging is C&D fines. The CDRA has long sponsored research by UFL on C&D fines, their varied makeup and attributes. Now the CDRA, with the support and management of the committee, is sponsoring a study into the interaction of C&D fines with a wood-derived biochar. The results of this study could effectively help tackle two of the most abundant and difficult materials to move, by creating an end market that combines them both together.

This theme was expanded on at the highly successful End Markets panel. Dr. Townsend of UFL presented on enhancing markets for recovered C&D derived products, specifically opportunities with C&D fines and wood-derived biochar. C&D fines are notorious for their heavy sulfate content, which comes from the breakdown of drywall in mixed piles. When fines with heavy sulfate levels get wet, they react with the water to create hydrogen sulfide, a compound that creates odors and poses health and safety concerns. At the same time, biochar is known to absorb hydrogen sulfide. By mixing biochar with C&D fines in simulated landfill reactors, the study was able to give proof of concept that biochar can reduce the hydrogen sulfide emissions from landfilled C&D fines.

The End Markets Development Committee will help direct this research as UFL enters the next phases of the study, where they will hone in on the optimal mix and then scale the study to validate the approach at an actual landfill site. Areas of interest during these next

phases include how the type of biochar impacts the mix, and the availability of that in the industry. Champion Waste and Recycling Services is an example of a CDRA member pioneering the production of biochar, and their presentation on the End Market panel was an inspiring glimpse into that. CDRA Recycler of the Year DTG Recycle rounded out the panel and demonstrated their commitment to furthering the reach of C&D recycling through creative and original programs that focus on connecting the need with the resource. The End Market panel was an excellent testament to the expertise that exists within the CDRA, and the potential opportunities that exist when we bring those elements together.

The enthusiasm and momentum behind the End Market Development Committee has been evident from its inception. It has garnered impressive support and participation from volunteers interested in being a part of this exciting work. Looking forward, it will continue to act as an incubator where innovation and industry can come together to identify opportunities for developing and expanding new end markets for the C&D recycling industry. As we take on some of the biggest challenges of our lifetimes within the industry, it remains clear that developing end markets will always be part of the solution. We look forward to being a part of that solution. **C&D**

Recycling Certification Institute Update The “What is Going On?” Edition

These are trying times for sure, but we are fortunate to report the Recycling Certification Institute is Open for Business and busy as ever. The home office is a safe place and we will continue to serve the C&D community.

In the previous issue we focused on quality vs quantity and identified several conflicts present in the system of rules and regulatory constructs. The coronavirus and subsequent shelter orders struck around the time that issue was published. What has happened since then? We are seeing a general decrease in both quality and quantity, with significant decreases in areas especially hard hit due to a variety of factors. Residue and ADC increases have been observed. Resource markets are struggling. C&D facilities have reduced staffing. The good news is that our diligence in following CDC protocols to prevent the spread of the coronavirus is making the light at the end of the tunnel a little brighter and closer. There is more good news for builders and facilities.

The USGBC recently assembled a meeting of expert stakeholders to discuss C&D recycling. The goal of the meeting was to have a dialogue among representatives of facilities, contractors and project teams, government, and USGBC and GBCI staff to explore ways to simplify the C&D recycling credit in LEED 4.1 while encouraging waste prevention through design, maintaining high diversion rates, and ensuring accurate project-level reporting.

Improvement opportunities worth exploring look to be further upstream, addressing what goes into projects versus focusing on what comes

out of the tailpipe. This would include harder-to-handle materials and materials that, once commingled, can become extremely difficult to recycle. Looking at addressing highest life-cycle impact materials currently in the waste stream is another area.

From a practical perspective, requiring an RCI-level certification for any mixed materials facilities used by projects was also discussed. Projects that didn't have access to an RCI-level certified facility would have the option of performing source separation instead. Increasing salvage and reuse is also an action discussed for consideration.

The direction of the dialogue was promising as there appeared to be consensus on the concept of an expanded menu of opportunities to maintain and increase diversion, address high-impact materials, improve quality of recovered materials, and ensure accurate project-level reporting. That brings us back to the focus on quality and quantity of materials coming into and out of C&D facilities. What gets measured gets managed.

The different perspectives on how to improve LEED 4.1 were appreciated and we extend our thanks to the USGBC for inviting RCI to contribute to this important dialogue. We look forward to the update on next steps. Until then, stay safe and healthy. **C&D**

Now is a great time to be pursuing any operational improvements that may be more difficult to do during full throttle mode.

Insurance Management- coverage is still needed and your next renewal will be underwritten, likely with even more scrutiny. Property, Auto and Umbrella markets continue to get more difficult. Legislative and Regulatory Committee Update

It has become increasingly obvious during the current pandemic how much State and local government influence the C&D Recycling industry. In addition to the “shelter-in-place” and other regulations that local officials had put on the general public, C&D recyclers were also affected by massive construction shutdowns and confusing determinations on what constitutes an “essential business.” Years of hard work and sacrifice, many of them in family run companies, have been wiped out or severely affected.

The CDRA Legislative Committee has never been so important, to impact the things we can, and to work with other organizations to develop responses on various issues. For example, the CDRA co-signed two separate letters, one to Congress and the other to the White House, asking for their support for the infrastructure legislation going through Congress. Infrastructure projects are a major end market for our industry, from recycled concrete base to mulch. There is large overlap between our committee and the End-Markets committee, and we continue to work together to provide solutions.

Please stay tuned for the CDRA to develop strategies to become more active in governmental actions.

Here are some other projects the committee has been working on:

- The CDRA has developed a Roadmap document to serve as a guide when local governments are setting up new regulations that affect the nature of our business. Our goal is to have them fully understand all angles to correctly implement solutions. All recycler members should download that document and share it with their regulators. The Roadmap document is also available for free to any government official.
- Committee work continues on updating the popular 50-state profile of C&D regulations. We will continue to provide members the names of the state officials who handle C&D issues, in addition to highlighting links to regulations that are related to C&D, in each state.
- Several committee members have been working with the U.S. Green Building Council on improving the MR recycling points under the LEED program. While well intentioned, the way the credit is written often does not make sense in the field. Our members have expressed frustration as their teams continue to spend time educating their customers and countering misunderstanding. Topics include better defining material “streams” and tackling the mostly unachievable “total weight reduction” portions of the credit.

- We have also been working with the USGBC to explain member feedback that the current Covid-19 period had been anything but normal. Maintaining our usual high recycling rates is not possible. Facility certification becomes an important discussion topic as real rates have fallen, but local governments and Point Reviews under-score some facilities who have reported increasing diversion. Our committee is dedicated to transparency and accurate reporting on this subject. Please contact me or Bill Turley if you are having an issue surrounding this matter.

- We are about to release a calculator that will allow C&D recycling facilities to determine the environmental benefit they are providing to their local communities. For example, you will be able to plug in your facility concrete tons recovered in the previous year, and the calculator will tell you how much equivalent gasoline was saved, or similar concepts. This will be available to members only on the website. [C&D](#)
