C&D Hall of Fame

This institution is to honor those prominent leaders and pioneers in the Construction and Demolition Recycling industry who have made an extraordinary contribution to the industry and who have earned the respect of the industry. Additionally, to honor those who have made an extraordinary contribution to their community, both personally and professionally.

Executive Director's Message OSHA Inspects Mixed C&D Recycler for Silica Exposure

CDRA Mission Statement

CDRA promotes and defends the environmentally sound recycling of Construction and Demolition (C&D) material through a diverse and unified voice of members committed to sustainability.

CDRA member reported that the local OSHA inspector came into his mixed C&D recycling facility for a typical inspection, and did find a few minor infractions. Easy to do with just about any operation. But apparently the federal employee also checked the facility's level of silica exposure to its employees, as part of the new regulation the agency started enforcing late last year.

We expected this testing at concrete recycling facilities when OSHA got around to the recycling industry, as the rule does cover the entire construction industry, covering a wide swath. Concrete is largely made up of silica, a ubiquitous material. Plus, recent news came out that the agency was down 40 inspectors, with no funds to replace them. So for OSHA to expend resources to investigate silica at a mixed C&D facility is an unexpected development.

Of course, at a mixed C&D operation there is less possible silica dust than at a concrete recycling operation, let alone other construction operations that are dustier, such as at concrete sawing and drilling. And in this instance the levels of silica turned out to be below the new, ridiculously low emission standards. But this shows that perhaps mixed C&D facilities will not be immune from scrutiny by OSHA on this issue.

Please let the CDRA know of any OSHA inspections for silica at your concrete recycling or mixed C&D facility. We have already developed information for concrete recyclers on the requirements of the rule. Please contact us at info@cdrecycling.org for more information.

CDRA Outreach

C&D World remains the premiere C&D event in North America. But as part of its mission to promote the viewpoint of C&D recyclers, the CDRA exhibits and participates in several other industry related events. For example, after C&D World February 10-13 in Nashville, CDRA will exhibit at the National Demolition Association meeting in Austin and WasteExpo in Las Vegas. Legislative/Regulatory Committee Report

The CDRA's Legislative Committee has been actively monitoring or working on issues that affect the C&D recycling industry. Our work has an impact on every business in the sector, and we urge you to provide us input on any of these issues, as well as alert the committee to needed work on other issues.

- OSHA's employee silica exposure rule is now in effect, although we have not heard of any CDRA members being inspected for how silica exposure they subject their employees to. Your association has submitted questions on the rule for clarification to OSHA, and we will share those answers when we get them. This rule affects concrete recyclers, and for its members CDRA prepared information on how to comply with the new rule. Please contact CDRA headquarters at info@cdrecycling.org if you need that information.
- The U.S. Environmental Protection Agency's Sustainable Materials Management in the Built Environment project will be proceeding with a meeting of invitation-only stakeholders Jan. 30 to Feb. 1 in Washington, DC. The CDRA has been a major driver of this conference, as we want the focus to be more on end of life issues in green building and sustainable materials management. Another issue is "green" building materials now used that will have no end-of-life options outside of the landfill. We contend any product that does not have a chance to be recycled or reused should not be considered green.
- Dr. Tim Townsend's work on C&D fines continues at the University of Florida. He and his team are now visiting selected C&D recycling facilities across the United States to do more in-depth analysis.
- Another project Townsend's team is working is an update of C&D regulations of all 50 states. The project was first completed four years ago, and as we all know there are changes in those rules on a regular basis. For example, New York's Department of Environmental Conservation did a major overhaul of its waste regulations that was announced earlier this year, and those rules seriously affected C&D in the state. In addition to a regulation update, we will be adding information on what each state considers C&D biomass, and, it stance on C&D fines.

• A material some find challenging to recycle is gypsum. A few years ago, the European Union developed a protocol on the recycling of gypsum. While that document will not work perfectly in North America, the CDRA has tasked Dr. Townsend into revising the protocol into something we can promote over here. Note that gypsum, besides being difficult to recycle, also contaminates C&D loads, making them more challenging to recycle, or in the case of C&D fines, even to dispose of because of the odors that can be created in landfills.

Again, please let us know if any issues you think the CDRA should be working on. We would really like to hear from you, our members..

Recycling Certification Institute Update LEED v4: Mixed C&D vs. Source Separation of C&D Materials

question came to us the other day regarding LEED points available for C&D recycling and whether or not source separated C&D was required. The source separation requirements are a bit of a tricky matter, but let us attempt to clarify with the assistance of the USCBC. While there are several LEED project categories to which this applies, the following is a general amalgamation of the requirements.

LEED v4 eliminated recycling credit for the use of alternative daily cover. It also created separate streams of C&D materials that would be counted as part of the recycling and/or waste reduction activities necessary for a project to earn one or two C&D-related points.

The first option (waste diversion) has two paths available: To earn one (1) point a project must divert 50% of the total C&D material and the diverted material must include three material streams. Or to earn two (2) points a project must divert 75% of the total C&D material and the diverted material must include four material streams.

The second option (waste reduction) has one path: A project may earn two (2) points by generating no more than 2.5 lbs of construction waste per sqft of the building's floor space. This second option is not relevant for our discussion here. What is meant by the first option's two paths is that in addition to recycling mixed C&D materials, projects must also source separate C&D materials for recycling. An example of this would be placing bins onsite for metals, wood, drywall, etc. If you remember the repetitive breakfast cereal commercials that ran during Saturday morning cartoons, the outcome of the requirement is quite similar to the phrase "..... cereal is part of this nutritious breakfast", except in this case, recycling mixed C&D is a necessary part of this waste diversion equation.

The bottom line is this: Mixed C&D recycling is still embedded in LEED v4. And the MRpc87 Pilot Credit point is still available for projects taking their materials to facilities Certified by RCI regardless of the recycling rate. You can "Get Started" on your RCI Certification by visiting https://www.recyclingcertification.org/.
